

COMPETITION TERMS

ABSOLUT X TOMORROWLAND (the “Competition”)

Organizer: The organizer of the Competition is Pernod Ricard Denmark AB (“Organizer” or “we”) with the address Vesterbrogade 149, 1620 Copenhagen, Denmark. For any inquiries, please contact us via email at pr-denmark.info@pernod-ricard.com. The Organizer reserves the right to change the Competition terms without prior notification and to suspend or cancel the Competition for objective reasons.

Competition Period: 2026-04-22 to 2026-06-10 (the “Competition Period”).

Eligibility: To participate in the Competition, you must (i) reside in Denmark, (ii) be at least 18 years old and (iii) be able to prove your identity and age at the Organizer’s request. The Plus One (as defined below) must also fulfil these conditions to be eligible to receive the Prize.

Ineligibility: The following categories of people are not eligible to enter the Competition: (a) officers, directors and employees of the Promoter, its parents, subsidiaries, or affiliates, (b) individuals or entities responsible for the development and implementation of this Promotion, and any employees, officers or directors of any corporate body responsible for the same, (c) employees working for suppliers, distributors and retailers of alcoholic beverage products, and (d) individuals who are employees of, or members of the immediate family or household of, any of the above categories.

No Purchase Necessary: You do not need to purchase anything to participate in the Competition. A payment or purchase will not improve your chances of winning a Prize.

How to Enter: To participate in the Competition, you must access the website <https://www.absolut.com/en/campaign/vindbilletter/> and follow the entry instructions available therein before the end of the Competition Period. Entries received will be considered final by the Organizer. Late or incomplete entries will not be accepted. And will be selected at random from the pool of all participants answering the mentioned question correctly.

Selection of Winners: Three (3) Winners, who win the Prizes, will be selected out of those who respond correctly to the questions on the Website and, The three winners will be contacted personally via the email address and phone number provided when entering the Competition. In this email, the winner will receive further instructions on how to collect the prize. The winner must confirm acceptance of the Prize by return e-mail no later than seven (7) days after dispatch of the Winner Notification. If the winner does not confirm acceptance, the Organizer reserves the right to award it to another participant. Unsuccessful entrants will not be notified directly.

Entry Limit: Only one Competition entry per competitor is accepted.

Prize: Full Madness Pass/REGULAR TICKET FULL WEEKEND 2 to Tomorrowland 2026, valid during Friday 24 July – Sunday 26 July 2026 for the winner and a friend of the Winner's choice (the "Plus One"), with a value of approx. DKK 3,000 per ticket. Three (3) Prizes of two tickets will be awarded. For the avoidance of doubt, the Prize does not include travel, accommodation or food to, from or during the festival. The Prize cannot be transferred or changed. It is not possible to exchange the Prize for cash or any other item of value.

Winner Notification: The Winners will be contacted personally, after the end of the Competition Period and all entries have been reviewed, via the email address provided by them when entering the Competition. In the Winner Notification, the Winner will receive further instructions on how to collect the prize, including but not limited to certifying the age and identity of the Winner and the Plus One. The Winner must confirm acceptance of the prize by return e-mail no later than 7 days after awarding of the prize, otherwise Organizer reserves the right to award it to an alternative winner. Unsuccessful entrants will not be notified directly. Organizer undertakes no responsibility for the Prize; neither responsibility for defects nor product liability, etc.

Taxes: Each Winner is responsible for assessing its tax implications and paying any taxes due as a result of winning the Prize. The Winner is also responsible for informing the Plus One of the potential tax implications and duty to pay taxes for the Prize.

with, such activity. You agree that you will not do anything which is likely to bring us or any of our competition partners into disrepute or which might adversely affect our reputation or the Competition. If you are disqualified prizes may be withheld or withdrawn. You will not be compensated and you may be required to pay any costs incurred. Another entrant or winner may be selected at our discretion to take part in the Competition and win the Prize.

Organizer shall have full discretion to edit the entry material and license same to their affiliated market companies.
